NOTICE OF RACE

Organizing Authority: Indianapolis Sailing Club  
Indianapolis, IN 46256

1. **RULES.** These races will be governed by the Racing Rules of Sailing (RRS); the prescriptions of US Sailing; current class association rules, except as any of these are changed by this notice; and by the sailing instructions, all of which are stated in English.
2. **SAILING INSTRUCTIONS:** The Wednesday Night Races Sailing Instructions will be as posted on the ISC website ([www.indianapolissailing.org](http://www.indianapolissailing.org)), and posted on the official ISC bulletin board in the Clubhouse.
3. **COMMUNICATION.** While racing, from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. On the water, the Race Committee may make courtesy broadcasts to competitors on VHF radio channel 68.
4. **ELIGIBILITY and ENTRY:** These races are open to any Indianapolis Sailing Club (ISC) member **in good standing** or club guest (with the Commodore's permission) to race his or her sailboat in the appropriate class, subject to any respective class rules and measurement requirements. Any sailboat failing to comply with these eligibility requirements shall be prohibited from sailing in ISC Club Races and Regattas. To be considered an entry for a race, boats must report to the Race Committee **at a Mandatory Competitors Meeting, to be held at the Race Committee Boat 30 minutes prior to the scheduled Harbor Signal,** or, before they start their race. No advance registration is required.
5. **CREW LIMITATIONS:** All crewmembers and helmspersons shall be amateur sailors. Crewmembers are not required to be a member of any sailing organization.
6. **SCHEDULE OF RACES:** The complete schedule of races will be as posted on the ISC website ([www.indianapolissailing.org](http://www.indianapolissailing.org)), and posted on the official ISC bulletin board in the Clubhouse. All times published and posted are Eastern Daylight: May thru August: Harbor Signal 6:30 PM, Warning Signal 6:57 PM,

Preparatory Signal 6:58 PM, Start of first boat or boats 7:00 PM, and in September: Harbor Signal 6:00 PM, Warning Signal 6:27 PM, Preparatory Signal 6:28 PM, Start of first boat or boats 6:30 PM.

7. EQUIPMENT INSPECTION: A boat and its safety equipment may be inspected at any time for compliance with class rules and ISC safety rules, this notice of race and the sailing instructions.

8. VENUE: Racing will take place on Geist Reservoir, from the area immediately to the left of the mouth of the ISC harbor, downstream (to the right and ahead, to the reservoir dam).

9. THE COURSES: The type or types of race courses to be sailed will be announced at the Mandatory Competitors' Meeting. The course for each race will be posted on the sides of the RC boat at or prior to the warning signal for that race.

10. PENALTY SYSTEM. The One Turn penalty, RRS# 44.2 shall apply.

11. SCORING and RECORDING. The RC will chronologically record all finishes in all races it governs and post the results in the launch area, on the ISC website ([www.indianapolissailing.org](http://www.indianapolissailing.org)), and on the official ISC bulletin board in the Clubhouse.

12. SUPPORT BOATS. Support boats are marked with Safety Boat.

13. RISK STATEMENT. By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks, among which are strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship, loss of balance on an unstable platform and fatigue. Competitors participate in these races entirely at their own risk. See RRS #3, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the races.

14. INSURANCE. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1000 (US) per incident or equivalent.
